**PROCEEDINGS OF THE MAYOR AND COUNCIL

TAKEN AT A SPECIAL MEETING HELD ON THURSDAY**

The Mayor and Council of the Town of Berwick, State of Louisiana, met in special session at their regular meeting place, the Town Hall, Berwick, Louisiana, Thursday, May 23, 2013, at seven (7:00) o'clock p.m.

There were present: Council members Duval Arthur, Troy Lombardo, Damon Robison, Greg Roussel, and Edgar Thomas.

Absent: None

Mayor Ratcliff led the prayer.

Councilman Edgar Thomas led the Pledge of Allegiance.

The Mayor and Council of the Town of Berwick, State of Louisiana were duly convened as the governing authority of said Town, by the Honorable Louis Ratcliff, Mayor, who then stated that the Mayor and Council were ready for the transaction of business.

Item # 1 on the agenda – Receive, consider and take action on recommendation from the Planning and Zoning Board for Phase V of Renwick Subdivision.
